

2024-2025 Special Education End of Year Snapshot

Purpose:

The purpose of the Special Education End-of-Year Snapshot is to obtain data on students who were referred to, evaluated, and/or received special education services at any point during the reporting period.

Dependencies:

- Student has been assigned a SASID and/or a LASID
- Student has a record in the Special Education Participation file
- Student has a record in the Special Education Child file
- Students who are part of a district will have records in the Student Interchange
 - Student Demographic file
 - Student School Association file
 - LASID should match the district/Student Interchange LASID

Criteria:

For a record to be added to the Special Education EOY Snapshot it must:

- be included in both the Child File and the Participation File with a matching SASID/LASID combination in each
- be error free in both the Child File and Participation File

Pull all error-free records from the Special Education Participation File that match the above criteria **EXCEPT** those with a PAI code of 23, 24, 31, or 32 or a Special Education Part C Referral code of 00.

- The Student Interchange is the primary source for SASID, LASID, Student's First Name, Student's Middle Name, Student's Last Name, Gender, Date of Birth, Ethnicity, Race, and Grade Level
- Data pulled from the Student Profile Interchange will be the non-tagged data
- If the record is not submitted in the Student Interchange, the demographic fields listed above will be pulled from the Special Education IEP Interchange
- The Special Education Child, Participation, and Student Interchange files will be joined based on the following criteria: SASID, LASID, School Year, Admin Unit (or district), and error free records

For records not submitted in Primary Interchange File (1.), data will be pulled into the snapshot from Secondary Interchange File (2.)

Student's Federal Race

The single category used in the snapshot to classify the student's federally designated race. This designation is based on the race and ethnicity reported by the district.

Code	Description
01	American Indian or Alaska Native
02	Asian
03	Black or African American
04	Hispanic or Latino
05	White
06	Native Hawaiian or Other Pacific Islander
07	Two or More Races

- If Student's Ethnicity: Hispanic/Latino = '1' then Student's Federal Race = '04'
- If Student's Ethnicity: Hispanic/Latino = '0' and only one of the following fields = '1', use the below logic to set Student's Federal Race
 - If Student's Race: American Indian = '1' then Student's Federal Race = '01'
 - o If Student's Race: Asian = '1' then Student's Federal Race = '02'
 - If Student's Race: Black = '1' then Student's Federal Race = '03'
 - If Student's Race: White = '1' then Student's Federal Race = '05'
 - o If Student's Race: Native Hawaiian = '1' then Student's Federal Race = '06'
- If Student's Ethnicity: Hispanic/Latino = '0' then Student's Federal Race = '07' when more than one of the following fields = '1'
 - Student's Race: American Indian
 - Student's Race: AsianStudent's Race: Black
 - Student's Race: White
 - Student's Race: Native Hawaiian

English Learner Status (ELL)

The English Learner (ELL) status for the student record. If the student's Language Background is not 'eng' and Language Proficiency = 1, 2, 6, or 7 (NEP, LEP, FEP Monitor Year 1, or FEP Monitor Year 2) then the ELL status is '1' (Yes). Students with Language Proficiency = 0, 4, 5, 8, 9 (N/A, PHLOTE, FELL, FEP Exit Year 1, or FEP Exit Year 2) are indicated as '0' (No)
